The processing of this information is tied to the final quality of the product we offer, if the lenses aren't produced with the correct values and parameters, the client will return the product and as it's individualized, it cannot be sold to someone else.

The GRCEssentials work-based methodology provided us with a framework that helped us to identify gaps and optimize data processing and guarantee that data is strictly managed throughout the whole value chain which is of utmost importance as we produce products that are tailored to very specific and individual requirements of each client.

6. What changes have you planned to apply in your company after the GRCEssentials' implementation?

We will tight the controls on data processing and data protection in order to reduce the possibility of mistakes and miscommunication of important data. We identified ways to optimize this process and we intend to apply it.
