Was the overall implementation of GRC Work-based Methodology successful?

Proper Corporate governance, Risk management and Regulatory compliance (GRC), lies at the core of any profession. For the legal profession, GRC is pivotal and must be constantly taken into consideration.

Our services expand beyond those of a traditional law firm, into several areas like Corporate and Tax, Trusts and Private Client, Compliance and Regulatory and Procurement and Administrative which makes the five learning areas of the project directly related to what we do.

We also found the combination of Project Governance and Data Governance with the GRC scope, very innovative.

As far as the work-based methodology is concerned, it adds value to the project as it can serve as a walk-through guide after the training courses are completed.

What challenges have you faced during the implementation of GRCEssentials Work-based Methodology?

Project Governance and Data Governance were relatively new areas for our firm.

At the same time, they are both extremely important, especially data governance, given the recent enforcement of the GDPR regulation across Europe which entered into force on 24 May 2016 and applies since 25 May 2018.

Corporate Governance is a topic of broad interest and challenging by nature. Its application deals with the business interactions within a company and implementing the proper checks and balances at all levels. It is also involved with both the day-to-day management as well as the strategic issues of the organisation. What is also important to note is that there is no "one size fits all" approach as each organization is unique which makes things even more complicated.

From the adoption of GRCEssentials work based Methodology, have you solved company's problems related with GRCEssentials five areas? (If yes, please mention them)

I would say that the GRC Essentials work-based methodology helped our team identify potential areas of improvement rather than solve any specific problems.

All areas are important but if we would have to choose, I would most probably say that Risk Management and Project Governance are the two areas where we benefited the most.

6. What changes have you planned to apply in your company after the GRCEssentials' implementation?

I am not sure it would be appropriate to pinpoint a specific change we implemented. What is important to say is that the knowledge we got from the knowledge areas of the project and the work-based methodology has allowed us to gain a better understanding on how corporate governance, risk management, regulatory compliance, project governance and data governance can be properly implemented and how it can benefit our organization. The same applies for how it can add value to our customers and stakeholders.

7. What would be your advice to other organisations so that they can better apply the GRCEssentials implementation process?

Our recommendation is to follow through with all project products. Most companies will need to start this new endeavour by evaluating and reading the Curriculum to gain an overall view of the project's learning areas. This will then allow them to jump into the implementation part and put things in the right order. Putting things in order is essential for all five areas. If we can discuss for example the corporate governance area, defining the organisation's vision, values and mission and deciding its strategic goals is a crucial steppingstone for building a sustainable organisation. The Work based methodology will complete the equation.
